Re: Dinghy storage on Waldringfield foreshore

I believe you wish to apply for a licence to keep a dinghy on Waldringfield foreshore for the 2012 season.

Please can you read the WFC rules before completing the form so that you are know which rules may affect you. Please may I request that when tying a dinghy painter to a mooring strop that this is done in such a way as to minimise the combined length and thereby mitigate the risk of it becoming a hazard.

Please can you fill in all the relevant boxes overleaf in the "Licence Holder record form for 2012" and send me the whole form with a cheque for £15.

Please write one of the following in the mooring type box:-

- If you keep your moored craft on a Waldringfield Boatyard site write "WBY".
- If you have been allocated a sailing club mooring please write "WSC".
- If you have been loaned a mooring please write "LOAN" and the mooring number.
- If you do not have a moored craft please write "NONE".

You must also include a stamped addressed envelope so that I can send you the dinghy licence sticker.

If you have any questions please contact me by either phone or EMail. On behalf of the WFC I hope that you have an enjoyable season at Waldringfield.

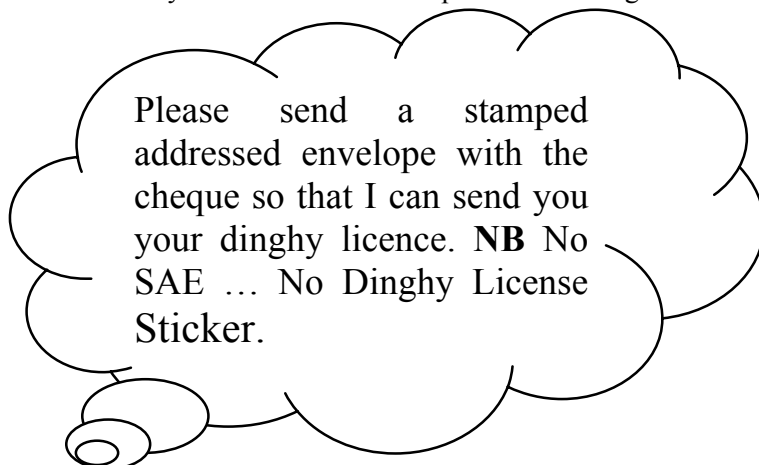
